including various scenarios of persons and corporations subpoenaed to appear and/or produce documents before a grand jury. It will include general information on what is a grand jury as well as do's and don't's of grand jury practice and appearances.

Attention will be given to Witnesses and Targets, target letters, invitation letters, subpoenas, motions to quash, rights and potential conflicts. The workshop will also cover issues related to document production, the need to assert privileges (obviously by first reviewing the documents yourself), calling the prosecutor and requesting time. Subpoenas Duces Tecum. Who do you represent? Privilege Log (privileges recognized under the law of PR, attorney client privilege, etc.)

Also covered will be post-indictment, pre-trial practice related to the Grand Jury, including expiration of Grand Jury term, violations of Grand Jury secrecy rules, composition of Grand Jury, oath of witnesses, and materially false testimony before the Grand Jury.

- Individual with a target letter
- Small Corporation with privilege
- 5th Amendment privilege
- Individual with a Subpoena
- Document production
